**Update of Center Gym (STEAP Grant) Project:**

- Pelletier Contract Draft
  - Chairman Rowland said that the Board of Selectmen approved the Center Gym Award at their February 14, 2024 meeting, and we will exercise the spiral duct alternate.
  - A draft contract has been received and after it is reviewed by Chairman Rowland and Anthony Genovese, it will be sent to the Town Attorney. After that, Mr. Genovese will send it to the State OPM for review.

**Center Building Renovation Project:**

- Receive Update from SP&A (Phase I)
- Review SP&A Probable Cost (Detailed) Estimate
  - Michelle Miller presented and reviewed the Phase 1-5 Project Summary, Conceptual Design – Opinion of Probable Construction Cost documents. General discussion took place.
  - Chairman Rowland suggested we try to split up the project and start with the exterior envelope of the building. He noted that electrical and mechanical upgrades are needed, and suggested the generator be outside instead of in the basement. Further discussion took place regarding the phasing of the project.
  - EOC Funds: Mr. Genovese said there are grant funds available through the federal government.
  - Chairman Rowland asked Ms. Miller to:
    - Invite Bob Banning to our March meeting to further discuss mechanicals.
    - Get an estimate that includes the cost of all departmental relocations.
    - Get an estimate for just the building envelope work, including the ramp, and put together a quick summary of the building envelope cost with an updated estimate.
