

**INLAND WETLANDS AGENCY
TOWN OF WOODBRIDGE
SPECIAL MEETING OF JULY 3, 2019**

A special meeting of the Inland Wetlands Agency for the Town of Woodbridge was held on July 3, 2019, in the Central Meeting Room of the Town Hall, 11 Meetinghouse Lane, Woodbridge, Connecticut.

Application for Eagle Scout Project of replacement of pedestrian footbridge for hiking trail

The Chairman noted that the purpose of the special meeting was to allow for action by the Agency on the subject application.

AEO Gilbertson reported on his pre-construction meeting with the applicant, Dominic Rendero and his coach, Bart Piccirillo of the Bethany Land Trust. He noted:

- The project will take place very close to the road. He had asked that the brush be cut prior to the start of the project and that he would arrange for the Town Public Works Department to take the cut brush away.
- Since the activity would take place close to the road, he would ask the Town Public Works Department to post “men at work” signage when the project is being worked on for safety purposes.

After a brief discussion, Agency members acted as follows on the application:

**** Josephs moved to approve the application by Eagle Scout candidate Dominic Rendero for replacement of a pedestrian footbridge for the hiking trail located on Town owned property at 35 Sanford Road subject to standard conditions and oversight by the Agency’s AEO.**

The approval was based on there being minimal or no impact to the onsite stream and wetlands if work was done in accordance with the plans and work schedule submitted with the application.
