### **SPECIAL TOWN MEETING AND ANNUAL TOWN MEETING MONDAY, MAY 19, 2025 - STARTING AT 7:30 P.M. CENTER BUILDING GYMNASIUM, 4 MEETINGHOUSE LANE, WOODBRIDGE, CT**

Electors and citizens qualified to vote in a Town Meeting of the Town of Woodbridge are hereby notified and warned that a Special Town Meeting will be held on Monday, May 19, 2025, at 7:30 P.M., to be immediately followed by the Annual Town Meeting, in the Center Building Gymnasium, 4 Meetinghouse Lane, Woodbridge, CT, to consider and take action on the following:

- I. Special Town Meeting pursuant to §§ 3-2 and 4-8 of the Town Charter to consider and act on the Land Lease Option and Lease Agreement between the Town and Greenskies Clean Energy LLC for construction of an approximately 1 megawatt solar panel facility on the Town's former landfill, located at 85 Acorn Hill Road Extension.

#### **NOTICE**

Section 3-3 of the Town Charter provides that the quorum required for the opening of any special meeting of the Town Meeting shall be at least 100 persons qualified to vote therein.

Section 6-2(h) of the Town Charter provides that each and every recommended budget item shall be considered and that the budget as recommended by the Board of Finance shall be deemed to have been appropriated unless the sum is increased, decreased, or eliminated by a vote that meets all of the following conditions: (1) no recommended budget item may be increased to an amount which is greater than the original request for appropriation; (2) the total number of eligible voters present and voting when each question is put to a vote equals not less than 250; and (3) the votes in favor of the motion to increase, decrease or eliminate constitute not less than 60% of the total number of votes cast.
