Connecticut General Statutes §12-63(b)(7) states “for assessment years commencing on or after October 1, 2024,” a depreciation schedule “shall be applicable with respect to motor vehicles based on the manufacturer’s suggested retail price of such motor vehicles, provided no motor vehicle shall be assessed at an amount less than five hundred dollars”
