


Personnel Matters & Events



Incidents of Special Interest

On September 4th Woodbridge Police arrested a 29-year-old New Haven resident for Cruelty to Animals. After an extensive investigation, an arrest warrant affidavit was submitted to the court and approved. The individual arrested allegedly “dumped” his canine in Bethany.

On September 6th Woodbridge Police responded to a Mettler Street address on the report on an “Unwanted Person.” Investigation led to the arrest of a 68-year-old Hamden resident. He was charged with Violation of a Standing Criminal Protective Order.

On September 7th Woodbridge Police were dispatched to a Landin Street address on the report of a “Family Dispute.” Officers subsequently arrested a 62-year-old Woodbridge resident. He was charged with Assault in the 3rd Degree, Breach of Peace in the 2nd Degree, and Criminal Mischief in the 3rd Degree.

On September 9th Woodbridge Police returned to the Mettler Street address, again, on the report of an “Unwanted Person.” Officers promptly arrested a 68-year-old Hamden resident. He was charged with “Violation of a Standing Protective Order.”

On September 11th Officers served an arrest warrant that was issued by the Department of Adult Probation. A 42-year-old Woodbridge resident was taken into custody and charged with Violation of Probation.

On September 19th a 57-year-old Waterbury resident was arrested by Woodbridge Police, for an incident that occurred in March of 2025. He was charged with Conspiracy to Commit Cruelty to Animals.

Traffic Calming

The Woodbridge Police Department speed trailer was deployed in the area of 40 Beecher Road. With school in session, the speed trailer is utilized as a deterrent to erratic driving and speeding.

The Woodbridge Police Department speed trailer (we have two) was deployed in the 300 block of Rimmon Road. The Department has received a complaint from a local resident.

Officers conducted “Radar/Speed Enforcement” three hundred and twenty-nine (329) times during the month of September. These assignments occurred at various locations, with special emphasis on areas where accidents have occurred and complaints have been received.

Officers conducted “Deterrent/Traffic Safety Patrols on three hundred and thirty-seven (337) occasions. Deterrent/Traffic Safety Patrols focus on violations occurring at control signals, stop signs and other traffic related areas.

Woodbridge Police conducted sixty-three (63) motor vehicle stops during the month of September. Violators were cited for Speeding, Operating Without a License and Failure to Drive Right.
