

# WOODBRIDGE PD NEWS

## Incidents of special Interest

On August 5, Woodbridge Police responded to an Ansonia Road residence on the report of “Harassment.” Investigation led to the arrest of a 42-year-old Woodbridge resident. He was charged with Stalking in the 2<sup>nd</sup> Degree and Criminal Trespass in the 1<sup>st</sup> Degree.

On August 11<sup>th</sup>, officers responded to a Mettler Street address on the report of a “Domestic Dispute.” The investigation resulted in the arrest of the two residents. The male, 67, and female, 50, were both charged with Disorderly Conduct.

On August 16<sup>th</sup>, police responded to a Merritt Avenue home on the report of a “Domestic Dispute.” Upon entering the residence, officers observed the 35-year-old tenant attempting to assault his brother. He was subsequently arrested for “Disorderly Conduct.”

On August 18<sup>th</sup>, Woodbridge Police again responded to an Ansonia Road residence on the report of “Harassment.” Officers again arrested a 42-year-old Woodbridge resident. He was charged with Criminal Violation of a Protective Order, stalking in the 1<sup>st</sup> Degree, threatening in the 2<sup>nd</sup> Degree, Harassment in the 2<sup>nd</sup> Degree, Breach of Peace in the 2<sup>nd</sup> Degree and Interfering with a Police Officer. He was detained on a \$100,000.00 bond.

On August 24<sup>th</sup>, officers again responded to a Mettler Street residence on the report of an “Unwanted Person.” Police located the 67-year-old Hamden resident and charged him with Violation of a Standing Criminal Protective Order. He was detained on a \$1,000.00 bond.

On August 25<sup>th</sup>, Woodbridge Police responded to a Mettler Street address on the report a “Protection Order Violation.” Officers quickly arrested a 41-year-old New Haven resident. He was charged with “Criminal Violation of a Protective Order.” He was held at Woodbridge Police Headquarters on a \$1,000.00 bond.

## Traffic Calming

The Woodbridge Police Department speed trailer was deployed around 334 Rimmon Road. The Department received a complaint from a neighborhood resident.

With school now in session, a speed trailer was deployed on Newton Road. The Department has received a complaint from a local resident.

The speed trailer was deployed on Bradley Road at the request of several members of the new Toll Brothers development.

A speed limit sign was installed northbound on Pease Road.

Woodbridge Police Officers conducted 340 radar speed enforcement assignments and 332 deterrent traffic safety patrols.

Officers conducted ninety-six motor vehicles stops during the month of August.
