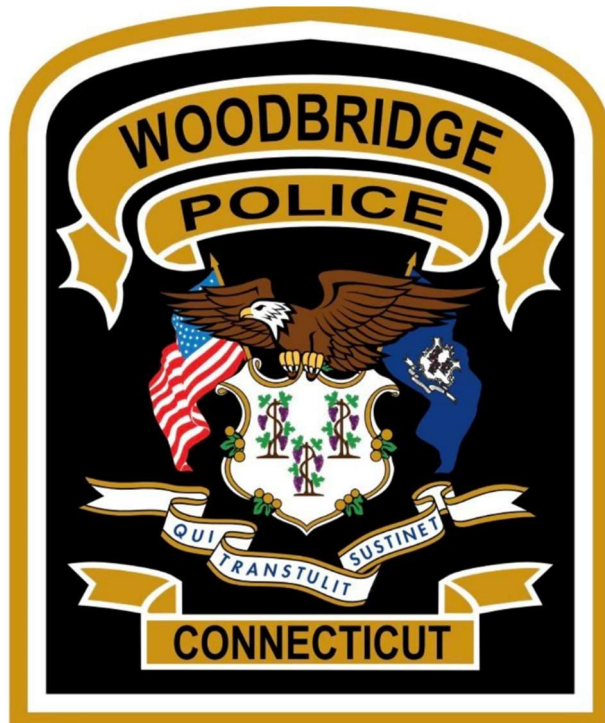

## Incidents of Special Interest

On December 3, 2025, members of the Woodbridge Police Department responded to a Litchfield Turnpike business on a report of a group of unwanted persons who stole merchandise. Following an investigation, officers arrested a 30-year-old New Haven resident. The individual was charged with Larceny in the Sixth Degree.

On December 6, 2025, members of the Woodbridge Police Department conducted a motor vehicle stop on Meetinghouse Lane. Officers arrested a 66-year-old Waterbury resident who was operating a motor vehicle without the required minimum insurance.

On December 13, 2025, members of the Woodbridge Police Department responded to an Amity Rd address on a complaint of an assault. Officers subsequently arrested a 61-year-old West Haven resident who was charged with Breach of Peace in the Second Degree, Assault in the Third Degree, and Threatening in the Second Degree.

On December 18, 2025, members of the Woodbridge Police Department responded to Dogburn Road in Orange, pertaining to a Woodbridge incident. Officers arrested an 18-year-old Orange resident who was charged with Breach of Peace in the Second Degree.

On December 18, 2025, members of the Woodbridge Police Department conducted a motor vehicle stop on Grant Street. The motor vehicle stop lead to the arrest of a 53-year-old Waterbury resident, who was operating a motor vehicle while under suspension. He was charged with multiple offenses, including Larceny of a Motor Vehicle and Reckless Driving.

On December 20, 2025, members of the Woodbridge Police Department responded to Heritage Lane on a report of a domestic dispute. Investigation led to the arrest of a 32-year-old Woodbridge resident, who was charged with Disorderly Conduct.

On December 21, 2025, members of the Woodbridge Police Department received a citizen complaint of an erratic driver. Officers responded to the area, the vehicle was located, followed briefly and Officers conducted a motor vehicle stop on Peck Hill Road. Officers arrested a 50-year-old Seymour resident, who was charged with failure to maintain proper lane and operating a motor vehicle while under the influence (DUI).

On December 24, 2025, members of the Woodbridge Police Department responded to Hallsey Lane regarding a 911 hang up. Following an investigation, officers arrested a 49-year-old Woodbridge resident, who was charged with Criminal Mischief in the First Degree, Disorderly Conduct, and Interfering with an Emergency Call.

On December 27, 2025, members of the Woodbridge Police Department responded to Lucy Street on the report of a family dispute. A 48-year-old New Haven resident was charged with Criminal Trespass in the First Degree, Criminal Mischief in the Second Degree, and Breach of Peace in the Second Degree.

On December 29, 2025, members of the Woodbridge Police Department responded to Mettler Street on a report of an unwanted person. Following a brief investigation, officers arrested a 68-year-old Hamden resident, who was charged with Violation of a Protective Order.

## Traffic Calming

The Woodbridge Police Department's speed trailers were deployed at the following locations:

- Beecher Road
- Center Road
- Pease Road

Officers conducted "Radar/Speed Enforcement" on two hundred and ninety-one (291) occasions during the month of October. Special emphasis was placed on school zones, recreation areas and the business sector.

Officers conducted "Deterrent/Traffic Safety Patrols" on three hundred and thirty-six (336) occasions. These patrols were focused on control signals, stop signs and other areas that have seen an increase in motor vehicle accidents.

During the month of October, Woodbridge Police conducted one hundred and two (102) motor vehicle stops. Violators were stopped for:

- Failure to Obey Stop Sign
- Failure to Remove Snow/Ice from Vehicle
- Failure to Renew Registration
- Operating without Insurance
- Speeding
- Traveling Unreasonably Fast
